The meeting was called to order at10.28am, followed by a word of prayer from Mrs. Mary Magero and introduction of members present.


#### b) Apologies

The secretary read the notice of the meeting.


#### MIN: SFB02/23/02/2023: REPORT ON DEMOLITION OF ILLEGAL STRUCTURES

The Municipal Board Chairperson welcomed the newly posted Chief Officer Mr. Solomon Abwaku.

Concerning reorganization and beautification of Busia Town:

- ➤ He was much elated towards the initiatives undertaken in the Municipality of Busia with an effort to re-organize and beautify the town which was spearheaded by the CECM-Lands, Housing and Urban Development and the Ag. Municipal Manager.
- ➤ He also stated that the public members were equally delighted by the changes the Municipal Management was effecting in town.

He then welcomed the Ag. Municipal Manager to present report on demolition and the following was noted:



- (i) A multi-agency committee was constituted that was chaired by County Commissioner and co-chaired by the CECM-Lands, Housing and Urban Development and various Sub-committees to implement action plans on challenges faced in the Municipality.
- (ii) The action plans included public sensitization done through electronic media thus radios, citizen forums, stakeholder meeting, issuance of notices among others.

It was also noted that:

- (iii) Public members cooperated in ensuring sanity is achieved in town.
- (iv) Programs on dualing of the Busia-Kisumu highway, creation of shoulders to be used by trailers, decongestion of town to eliminate traffic snarl ups, and maintenance of drainages on the Highway were being fast trucked by the multi-agency subcommittees in coordination with KENHA.
- (v) In addition the Contractor for the bus park was already on site and was to complete work in 18 weeks-time.

As rejoinder, upon interrogation of the report, it was advised that;


- > Reports presented to the Board to be in form of a request for adoption.
- ➤ In case of a report from external as appointed by the Municipal Manager, the same is to be owned by management before seeking adoption by the Board.
- ➤ The management in liaison with Trade to explore Korinda market as suitable to be a stall market for the Municipality.
- > In anonymity, the members were satisfied with the activities going on concerning reorganization and beautification of town.

## MIN: SFB03/23/02/2023: VALIDATION REPORT ON ALUPE COMPLEX ROAD FEASIBILITY STUDY

The Chairperson acknowledged receipt of the above report and invited the Ag. Municipal Manager to present to the Board.

The Municipal Manager stated that he:

The Board delved into the content of the report and unanimously agreed and resolved as follows:-


- The Board hereby adopts the report presented by Ag. Municipal Manager.

### MIN: SFB04/23/02/2023: ADOPTION OF MUNICIPALITY OF BUSIA DRAFT BY-LAWS 2023

The Ag. Municipal Manager-Busia made reference to section 21(1) of the Urban Areas and Cities Act 2011 (Araended 2019) concerning mandate of the Municipal Board to make Bylaws for effective management of the Municipality. Upon deliberation, members noted that indeed, the Municipality cannot effectively operate without Bylaws.

- 14. Public Markets Bylaw
- 15. Permits of Bicycles Bylaw



## 16. Commercial and Private Schools Bylaws
