THE BUSIA COUNTY FINANCE BILL, 2025**A Bill for**

AN ACT of the County Assembly of Busia to provide for measures to impose various taxes, levies, fees and charges in respect of services rendered by the County Government in the financial year 2024/2025; amend or vary various revenue raising laws and for other related matters incidental thereto

ENACTED by the County Assembly of the Busia, as follows—

PART I—PRELIMINARY**Short title and Commencement**

1. (1) This Act may be cited as the Busia County Finance Bill, 2024, and shall, subject to sub-section (2), section 25 of the County Governments Act, commence and come into operation upon publication in the *Kenya Gazette*.

(2) The Executive Committee Member may bring into operation different sections and /or Schedules or parts thereof at different times.

Interpretation

2. In this Act, unless the context requires a different interpretation—

“Agricultural services” include crop farming, horticulture, floriculture, livestock farming, veterinary services, fishing and fisheries, aquaculture and shall also include training services offered at the Busia Agricultural Training Centre and other training centers in the County;

“Blue economy” means the sustainable use of rivers, lakes and other water body resources in the County for economic growth, livelihoods, and jobs while preserving their ecosystem health;

“Carriage way” means one side of a road on which traffic travelling in opposite direction is separated by a barrier;

“County” means Busia County established under Constitution;

“Constitution” means the Constitution of Kenya, 2010;

“County Assembly” means the County Assembly of Busia established in accordance with the Constitution;

“County Government” means the County Government of Busia;

“County Executive Committee” means the County Executive Committee of Busia;

“Executive Committee Member” means the Member of the County Executive Committee responsible for matters relating to Finance;

“County Receiver of Revenue” means the public officer in the County Treasury appointed in accordance with Public Finance Management Act and the Busia County Revenue Administration and Management Act No. 11 of 2016.

“Cess” means the fee charged under and as defined in the County Cess Act;

“Dry rate” means a rate of hire of machine, plant or equipment only, excluding all that follows its use;

“Ratable Property” has the meaning given to it in the Rating Act, 2017 of the County;

“Registration of private mark” or “assignment of private mark” means registration or assignment of an identifying mark to a fishing vessel or gear as referred to in section 63 of the Fisheries Act, Cap. 378;

“Sub-divided “means graduated measure of capacity or measure of length with small divisions to the mark;

“Unsub-divided” means measure of capacity or length that is constructed to its equivalent value without any small divisions;

“Wet rate” means a rate of hire of machine, plant or equipment including all that follows its use.

PART II —TAXES, RATES, LEVIES, FEES, CHARGES AND OTHER RECEIPTS PAYABLE AND APPLICABLE

Power to impose tax and levy fees

3. (1) The County Government shall have power to impose taxes, levies, fees and charges on businesses, activities and services indicated in the Schedules herein and carried on or undertaken in the County or offered and provided by the County Government.

(2) Subject to the provisions of this Act, any laws, regulations, guidelines, directions, restrictions, orders or authorizations on or relating to financial management, including collection and administration of taxes, fees or charges, given or issued, enacted and or subsisting or valid in the County immediately before the repeal of the Local Governments Act (Cap. 265) shall be deemed to have been enacted, made, given or issued by the County Government until the expiry, amendment or repeal of such laws, regulations, guidelines, directions, restrictions, orders and authorizations.

Taxes and fees to be charged

4. The taxes, fees and charges set out in the charges column of the Schedules hereto shall apply at the rates indicated for the respective services, items or activities listed in the items description column of the relevant Schedule

Validity of fees, levies and charges before Act

5. The taxes, levies, fees and charges applicable and payable to the County Government at or immediately before the commencement of this Act, but which are not included in the Schedules to this Act, shall continue to apply under the specific and or general descriptions and legislation enacted by the County Assembly or Parliament as the case may be.

Fees in Agricultural and related services

6. The County Government shall levy and charge the fees prescribed in the First Schedule in respect of various agricultural services that it shall deliver in the County.

Fees on Impounded and attached property

7. The fees and charges prescribed in the Second Schedule, shall be imposed and charged by the County Government in respect of —

- (a) impounded or attached items, goods or any other property; or,
- (b) items, goods or other property stored or kept in a County yard or yards, store or stores after such impoundment or attachment.

Powers to levy charges or fees for attachment and training

8. The fees and charges prescribed in the Third Schedule shall be payable in respect of industrial attachment and training under this section.

Imposition of fees and charges for businesses and trades in the County

9. (1) The fees and or charges prescribed and set out in the Fourth, Fifth, Sixth, Eighth, Tenth and Eleventh Schedules shall be fees imposed and levied or charged by the County Government as Single Business Permit in respect of licences issued to businesses, trades and professions undertaken and or carried on in the County as indicated in the Item columns of the Schedules.

(2) For avoidance of doubt, and aware of the National legislation governing and regulating standards on measurements and weights in Kenya, the charges and fees charged under the Weights and Measures Act are hereby adopted and incorporated in Part I of Schedule 6 to this Act.

Licences in transport and roads sector

10. Whenever it shall consider it convenient and in the interest of the County, the County Government may lease or hire out to and for the use of

any person its construction machines, plants and equipment and levy and impose in respect thereof the fees and charges prescribed in Part 2 of the Fifth Schedule.

Payable Cess and market fees

11. (1) In accordance with the provisions of the County Cess Act, 2017 and the Trade Act and the Regulations made there-under, the County shall impose and charge in respect of the services given and delivered the cess and market and other fees and charges prescribed in the Sixth Schedule.

(2) For purposes of this section and the Schedule, a market place includes the market and its surrounding.

Fees and Charges for different services in respect of water and natural resources

12. To ensure the preservation and protection of the water and natural resources of, and the environment of in the County, the County Government shall impose the fees and charges prescribed in the Seventh Schedule to ensure effective and efficient delivery of the services offered and provided.

Applicable Fees and Charges for Consumables and other health services

13. For the purpose of ensuring that the County Government provides effective, efficient and quality health services in the County, the fees and charges prescribed in the Eighth Schedule shall be paid in respect of the services delivered and the commodities and consumables used.

Payment of rates and approved charges for building plans and imposition of rates

14. The fees, charges and rates prescribed and as indicated in the Items column of the Ninth Schedule shall constitute the rates, fees, charges and rent payable in respect of the various activities relating to property in the County and for various services under sections 15 and 16.

Payment and collection of land rates determined in accordance with the Rating Act

15. (1) In accordance with and pursuant to the provisions of the Rating Act, the taxes and levies set out in the Busia County Valuation Roll approved by the Busia County Assembly, shall be the rates payable in respect of the land and property as published in the Valuation Roll.

(2) In accordance with section 22 of the Rating Act, the Executive Committee Member may prescribe interest to be charged on any rates or any part thereof that may remain unpaid after the day on which the rates became payable.

Outdoor advertisement

16. The County Government shall take measures to regulate and control outdoor advertisements and signage in the County, the County Government hereby imposes charges or fees as set out in the Ninth Schedule.

Fees and Charges for establishment and operation of educational and training institutions

17. Every person who wishes to carry on or carries on business of an education or training institution in the County shall pay in respect thereof the fees and charges prescribed in the Tenth Schedule.

Promotion of tourism and social cultural integration and regulation of certain activities

18. The County Government shall impose the taxes, levies and or fees prescribed in the Eleventh Schedule shall be paid in respect of the services and activities stated in the Items column of the Schedule undertaken or carried out in the County.

PART III—MISCELLANEOUS PROVISIONS**Consequence of failure to pay tax or fees due**

19. Any person liable to pay or property subject to a tax, fees, levy or other charge who fails to make payment thereof within thirty (30) days from the date due shall pay a penalty of thirty (30) per centum of the amount payable for every thirty (30) days during which the amount shall remain due and unpaid.

MEMORANDUM OF OBJECTS AND REASONS

This Bill is prepared pursuant to Article 207 of the Constitution of Kenya, 2010, section 8 of the County Governments Act, 2012 and Standing Order No. 218 of the Standing Orders of the County Assembly. Under Article 175 of the Constitution, County Governments are required to have reliable sources of revenue to enable them to carry out their operations and effectively govern and deliver services. In accordance with the said article and pursuant thereto, this Bill seeks to provide for various taxes, fees and other charges to be imposed and or levied by the County Government of Busia in respect of services provided by the Government in the performance of its functions.

The taxes, fees and other charges as set out in the Schedules are divided into Parts according to the department of the County Government. The currency used is (KSh.).

Statement on delegated powers to legislate

Because the County Government may, in some instances, lack physical, administrative, infrastructural and human resources, the Bill empowers the Executive Committee member responsible for Finance to bring into operation the various provisions of the various sections of the schedules at different times as necessary and or experienced.

Operationalization of certain provisions of the proposed laws shall entail an expenditure of public funds which will be provided for in the estimates.
