## THE BUSIA COUNTY FINANCE ACT, 2020

A Bill for introduction in the County Assembly of Busia to provide for the various taxes, fees and charges for services and for the other revenue raising measures by the County Government; **to amend or vary various revenue raising laws** and for other related matters, connected and incidental thereto.

Enacted by the County Assembly of the Busia, as follows; -

### PART 1- PRELIMINARY

1. This Act may be cited as the Busia County Finance Act, 2019 and shall, subject to section 25 of the County Governments Act no. 17 of 2012, shall commence and come into operation, upon publication. The Executive Committee Member may bring into operation different sections and or Schedules or parts thereof at different times. Citation and Commencement
2. In this act, unless the context requires a different interpretation: - Interpretation
  - “agricultural services” include services given and delivered in veterinary, fisheries and training services at the Busia Agricultural Training Centre
  - “County” means Busia County;
  - “Constitution” means the constitution of Kenya 2010;
  - “County Assembly” means the County assembly established for the County in accordance with **Article** of the Constitution
  - “The County Government” means the county government for the County.
  - “The County Executive Committee” means the County Executive Committee of the County.
  - “The County Executive Committee Member” means the member of the County Executive Committee responsible for matters relating to finance in the County.

“The County Receiver of Revenue” means the public officer in the County Treasury appointed in accordance with Public Finance Management Act and the County Revenue Administration and Management Act.

“Cess” means the fee charged under and as defined in the County Cess Act.

“Rateable Property” has the meaning given to it in the Rating Act

## **PART II – TAXES, RATES, FEES, CHARGES AND OTHER RECEIPTS PAYABLE AND APPLICABLE**

3. **(1)** The County Government shall have the power to impose taxes, fees, charges and other receipts on businesses, commercial activities and on use of services and facilities offered by County Government. Power to impose tax and levy fees
  
- (2)** All laws, regulations, guidelines, directions, restrictions, orders or authorizations on or relating to financial management including collection and administration of taxes fees or charges given or issued enacted, and subsisting or valid in the County immediately before the repeal of the Local Governments Act shall be deemed to have been enacted, made, given or issued by the County Government until the expiry, amendment or repeal of such laws, regulations, guidelines, directions, restrictions, orders and authorizations.
  
4. Taxes, fees and charges set out in the charges column of the Schedules shall apply at the rates indicated for the respective services, items or activities listed in the items description column of the Schedules. Taxes and fees to be charged
  
5. The taxes, fees and charges applicable and payable to the Busia County Government at and immediately before the commencement of this Act, but which are not included in the Schedules to this Act, shall continue to apply under the specific and the general descriptions and legislation enacted by the County Assembly. Validity of fees and charges before Act
  
6. The County Government shall levy and charge the fees prescribed in Schedule 1 in respect of the different agricultural services that it shall deliver in the County. Fees in Agricultural and related services
  
7. The fees and charges prescribed in the Second Schedule, shall be imposed and charged by the County Government in respect of impounded or attached items, goods or any other property or, after such impoundment or attachment, stored or kept in the County yard. Fees on Impounded and attached property

8. (1) The County Government shall encourage and promote development and sharpening of skills in various fields in the County and may, for that purpose, take learners and trainees on attachment from learning and training institutions recognized by the National Industrial Training Authority. Charged in respect of attachment and training
- (2) Further, for the purpose of ensuring continuous education and improvement of service delivery in the County, the County Government may sponsor its officers to undertake specialized and other training in institutions recognized by the National Industrial Training Authority.
- (3) The fees and charges prescribed in the third Schedule shall be payable in respect of the attachment and training under this section.
9. The County Government shall impose the fees and charges prescribed in the Fourth, Fifth, Sixth, Eighth, Tenth and Eleventh Schedules as Single Business Permit in respect of licenses issued to undertaken and carry on the different businesses, trades and professions including manufacturing and industrial undertakings as indicated in the Item column of the Schedule. Fees for Single Businesses and trades
10. (1) Pursuant to and in accordance with the Fourth Schedule of the Constitution and the County Transport and Safety Act 2016, in order to effectively and efficiently deliver services in the transport and county roads sectors, the County Government shall impose the fees and charges prescribed in the Fifth Schedule. Licenses in transport and roads sector
- (2) The County Government may, whenever it considers it convenient and in the interest of the County, lease or hire out to and for the use of any person its construction machines, plants and equipment and the fees and charges in respect thereof shall be as prescribed in Part 2 of the Fifth Schedule
11. (1) In accordance with the provisions of the County Cess Act 2017 and the Trade Act and the Regulations made thereunder, the County shall impose and charge market fees, cess and other fees and charges prescribed in the Sixth Schedule in respect of the services given and delivered as indicated in the Item column thereof. Payable cess and market fees
- (2) For purposes of this section and the Schedule, a market place includes a market and its surrounding.
12. (1) The County Government shall ensure that the water and natural resources in the County are protected, conserved and utilized to promote productivity and ensure a clean and healthy environment for social and economic development of the County. Water and natural resources

(2) The County Government shall impose the fees and charges prescribed in the Seventh Schedule to ensure effective use and protection of water, natural resources and the environment.

13. (1) Pursuant to the Constitution, the County Integrated Development Plan and the relevant County laws, the County Government shall promote quality health services in the County.

Applicable Fees for health services

(2) The fees and charges prescribed in the Eighth Schedule shall be paid in respect of the services delivered and the commodities and consumables used as indicated in the items column.

14. (1) The County Government shall ensure proper land planning, use and development and it may, in accordance with the provisions of the Rating Act, impose and levy such tax on land or property as maybe necessary.

Approval of building plans and imposition of rates

(2) The County Government may lease or rent its property at such a rate as it may determine.

(3) The County Government shall take measures to regulate and control outdoor advertisements and signage in the County and may, for that purpose impose a charge or fees in accordance with this section.

(4) The fees, charges and rates prescribed in the Ninth Schedule shall constitute the payable rates, fees, charges and rent in respect of the various activities relating to property in the County and for various services as indicated in the Items column thereof.

(5) In accordance with **section** of the Rating Act, the Executive Committee Member may prescribe interest to be charged on any rates or any part thereof that may remain unpaid after the day on which the rates became payable.

15. (1) Every person intending to establish or carry on business of education or training in the County shall first apply for and obtain a license to carry on such business and no person shall carry on such business or activity without such a license.

Fees for establishment and operation of educational institutions

(2) The fees and charges prescribed in the Tenth Schedule shall be paid by every person who wishes to carry on and carries on business as an education or training institution in the County.

16. (1) The County Government shall integrate social, cultural and traditional heritage and take measures to promote community based tourism and sports in the County. Promotion of Tourism and social cultural integration and regulation of certain activities
- (2) The County Government shall promote responsible consumption of alcohol and engagement in gambling and betting activities in the County in accordance with the National policy and the provisions of the County Alcoholic Drinks and Control Act 2013.
- (3) The County Government shall impose the taxes and levy fees and other charges as prescribed in the Eleventh Schedule for the services and activities stated in the Items column thereof.

### **PART III- MISCELLENEOUS**

17. (1) All payments under this Act shall be made to the County Receiver of Revenue in accordance with the provisions of the County Revenue Administration and Management Act. Compliance with the Public Finance Management Act and the County Revenue Management and Administration Act
- (2) An official receipt shall be issued for all payments made to the County Receiver of Revenue.
- (3) Unless specifically authorized by law, a person shall not receive or collect money on behalf of the County Receiver of Revenue.
18. (1) Any property subject or liable to a tax or any business or person to pay a fee in respect of a service for a previous year or period which has not been paid shall, before receiving any other service first pay such tax or fees. Consequence of failure to pay tax or fees due
- (2) The Executive Committee Member may, with the approval of the County Executive Committee impose a penalty in respect of the arrears or part of the arrears outstanding and in default
19. The Executive Committee Member may, with the approval of the County Executive Committee exempt, waive, or vary, fees or charges payable under this Act as an incentive or relief. Power to exempt or waive fees
20. The Executive Committee Member may make Regulations for the better carrying out of the purposes and provisions of this Act. Regulation

## MEMORANDUM OF OBJECTS AND REASONS

This bill is prepared pursuant to Article 207 of the constitution of Kenya 2010, section 8 of the County Governments' Act 2012 and Standing Order No. 218 of the Standing Orders of the County Assembly.

Under Article 175 of the Constitution, county governments are required to have reliable sources of revenue to enable them govern and deliver services effectively. This Bill, therefore, seeks to provide for various taxes, fees and other charges to be imposed and or levied by the County Government of Busia in respect of services provided by the Government in the performance of its functions.

The taxes, fees and other charges as set out in the Schedules is divided into parts according to the departments of the County Government providing the various services. The currency used is Kenya shillings (Kshs)

### **Statement on delegated powers to legislate:**

The County Government may, in some instances lack physical, administrative infrastructure and human resources and for this reason, the Bill empowers the Executive Committee Member responsible for finance to bring into operation the various provisions of the Act or certain sections of the Schedule at different times as necessary.

Operationalization of certain provisions of the proposed law shall entail an expenditure of public funds which will be provided for in the estimates.
